**INVITATION TO BID**  
**PROVISION OF SECURITY SERVICES**  
**MULTI-YEAR CONTRACT 2017-2019**

1. The **National Telecommunications Commission – Region 7 (NTC-7)**, through the **Fund 101 /General Appropriations Act** intends to apply the sum of **Six Hundred Sixty One Thousand Pesos (₱661,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Provision of Security Services (Multi-Year Contract 2017-2019)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NTC-7** now invites bids for the **provision of security services of three (3) licensed security guards**. Delivery of the Goods is required **1 January to 31 December 2017**, renewal for two years. Bidders should have completed, within **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from **NTC-7 BAC** and inspect the Bidding Documents at the address given below from
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee in the amount of **One Thousand Pesos (₱1,000.00)**. The method of payment will be in the form of cash. The Bidding Documents shall be received personally by the prospective Bidder/s or authorized representative/s.
6. The **NTC-7** will hold a Pre-Bid Conference on **22 Nov. 2016 1:00pm**, at **NTC-7 Conference Room**, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before **05 December 2016 at 1:00pm**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bid opening shall be on **05 December 2016, immediately after the cut-off time at NTC-7 Conference Room**. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The **NTC-7** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
