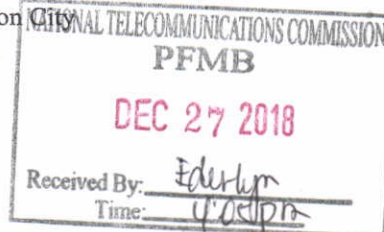

Deadline for the filing of applications shall be two (2) weeks prior to the date of examinations. The master list of examinees shall be submitted to the Radio Operators Examination Committee (ROEC) **within three (3) working days from the deadline of filing applications.**


In the interest of the service, NTC may conduct special Radio Operator's Examination, upon request subject to the approval of the Commissioner.

The Planning, Finance and Management Branch (PFMB) shall provide the necessary funding requirements, including the use of NTC vehicle for travel, for the effective implementation of the examinations subject to the usual accounting and auditing regulations.

This Order shall take effect upon signing and supersedes or amend any Circular/Order inconsistent herewith.
