MEMORANDUM CIRCULAR NO. __01=02=202@

SUBJECT: Further Amending Section 2 of Memorandum Circular No. 03-05-2007

Pursuant to Act 3846, as amended (Radio Control Law), Executive Order No. 546 series of 1979, and RA 7925 (Public Telecommunications Policy Act) and in the interest of public service and in order to keep pace with the development in wireless technology to ensure wider access to the limited radio spectrum and the use of cost-effective technology, Section 2 of Memorandum Circular (MC) No. 03-05-2007 is hereby further amended as follows:

OPERATING PARAMETERS

The limits of the technical parameters herein prescribed should not be exceeded by any function of the equipment or by any means.
