Invitation to Bid for the Procurement of One (1) Lot Multiband Network Scanning Receiver and Post Processing Tools in a Vehicle Project

1. The National Telecommunications Commission (NTC) Regional Office No. VII of Mandaue City, through FY 2019 GAA intends to apply the sum of **TWO MILLION FOUR HUNDRED THOUSAND PESOS (Php2,400,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for *Procurement of One (1) Lot Multiband Network Scanning Receiver and Post Processing Tools in a Vehicle Project*.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The NTC RVII now invites bids for *One (1) Lot Multiband Network Scanning Receiver and Post Processing Tool in a Vehicle Project for the Regional Office VII of the National Telecommunications Commission (NTC7)*. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.
3. Delivery to NTC Regional Office No. VII at Cor. M. Logarta & Lopez Jaena, Wireless, Subangdaku, Mandaue City shall be completed within *Thirty (30) calendar days from receipt of the Notice to Proceed*. Failure to complete the said delivery within the period stipulated would require the winning bidder to pay corresponding penalties/liquidated damages in accordance with Section VIII of the Bidding Documents.
4. The summary of the bidding activities is as follows:

5. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

6. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
7. A complete set of Bidding Documents may be acquired by interested Bidders on *August 16, 2019 to September 6, 2019* from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php5,000.00)**.
8. The Bidding Documents may also be downloaded free of charge from the website of the PhilGEPs and NTC website provided that Bidders shall pay the non-refundable price not later than the submission of their bids.

Interested bidders may inspect the Bidding Documents and obtain further information from the BAC Secretariat at the address given below from 8:00 am to 5:00 pm.
9. The National Telecommunications Commission Regional Office VII will hold a Pre-Bid Conference on August 23, 2019 at 2:00 p.m. at the NTC RVII Building Conference Room, Wireless, Subangdaku, Mandaue City, which shall be opened to all interested parties. Only those who have purchased the bidding documents may actively participate.
10. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
11. Bid opening will be conducted on September 6, 2019 at 2:00 p.m. at the NTC RVII Building Conference Room, Wireless, Subangdaku, Mandaue City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the opening. Late bids shall not be accepted.
12. Bidders shall drop their duly accomplished eligibility requirements, technical and financial proposals in two separate sealed envelopes in the designated bid box located at the bidding room.
13. The National Telecommunications Commission RVII, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
